Pursuant to Article 114, and in connection with Article 37, Paragraph 6 of the Law on Higher Education ("Official Gazette of the Republic of Macedonia" No. 82/18 and "Official Gazette of the Republic of North Macedonia" No. 178/21 and 58/24), Article 65 of the Statute of the Ss. Cyril and Methodius University in Skopje (University Gazette No. 425/19) and Article 57 of the Statute of the Faculty of Medicine within the Ss. Cyril and Methodius University in Skopje (University Gazette No. 458/19 and No. 458/21-annexe), on 24.11.2025, the Dean of the Faculty adopted the following

DECISION

On announcing elections for President and members of the Faculty Student Assembly of the Faculty of Medicine in Skopje

Article 1

We hereby announce the elections for President and 24 (twenty-four) members of the Faculty Student Assembly of the Faculty of Medicine in Skopje.

Article 2

The elections for President and members of the Faculty Student Assembly shall be held by secret ballot online on 25 December 2025 (Thursday), through a licensed electronic voting platform, which shall guarantee the secrecy of the vote, between 10 am and 5 pm.

Article 3

An election commission is hereby appointed to conduct the elections for President and members of the Faculty Student Assembly of the Faculty of Medicine in Skopje, with the following composition:

1. Dr Anita Arsovska, full professor at the Faculty of Medicine in Skopje;
2. Dr Aleksandar Stankov, full professor at the Faculty of Medicine in Skopje;
3. Vladimir Anevski, a first-cycle student, enrolled in the sixth year, in the XI semester, at the study program General Medicine, with index number 19586;
4. Eva Blazhevskaja, first-cycle student, enrolled in the sixth year, in the XI semester, at the study program General Medicine, with index number 19594;
5. Angela Kostova, a first-cycle student, enrolled in the fifth year, in the IX semester, at the study program General Medicine, with index number 20001.

Article 4

The Election Commission referred to in Article 3 of this decision shall:

- implement the election procedure/s;
- adopt a decision stating that the proposed candidates meet or do not meet the requirements to be proposed as members of the Faculty Student Assembly. The decision shall include the personal name of the candidate, whether he/she is enrolled in the semester, i.e., in the year of holding the elections, the academic year, the study program, etc. The decision of the Commission shall be final;
- determine the results of the voting procedure;
- compile minutes of the results of the Faculty's voting procedure and the final result;
- perform other tasks for the purpose of conducting the elections.

The Election Commission shall adopt Instructions determining the manner of work, the manner of voting through electronic means, the form of the minutes, the method of counting the votes, the result of the voting procedure, notifications, etc., storage and inspection of the election documentation and other issues related to the procedure for organizing the elections, voting and determining the results of the vote.

The instructions shall be published on the Faculty's website, no later than 7 (seven) days before the elections are held, along with the decision establishing whether the proposed candidates meet or do not meet the requirements.

Article 5

The Election Commission referred to in Article 3 of this Decision shall be obliged to conduct the elections for President and members of the Faculty Student Assembly of the Faculty of Medicine in Skopje in accordance with the Law on Higher Education, the Statute of the Ss. Cyril and Methodius University in Skopje and the Statute of the Faculty of Medicine in Skopje within the Ss. Cyril and Methodius University in Skopje.

Article 6

Students shall personally submit their applications for candidates for President or members of the Faculty Student Assembly to the Election Commission, through the Faculty's archive or via email to the Faculty's official email address (medf@medf.ukim.edu.mk), no later than 10 (ten) days before the elections are held, i.e. no later than 15.12.2025 (Monday).

The application for a candidate for President and member of the Faculty Student Assembly must include the student's first and last name and index number.

The Faculty Student Assembly is composed of student representatives by years of undergraduate, postgraduate and doctoral studies, as follows:

- four first-year representatives of all study programs at the Faculty;
- four second-year representatives of all study programs at the Faculty;
- four third-year representatives of all study programs at the Faculty;
- three fourth-year representatives of the General Medicine study program and the four-year academic studies for a Graduate Speech Therapist;
- three fifth-year representatives of the General Medicine study program;
- three sixth-year representatives of the General Medicine study program;
- one representative of the postgraduate studies in the field of public health and
- two representatives of all doctoral study programs.

Article 7

Based on the applications submitted by students for candidates for President or members of the Faculty Student Assembly, the Election Commission shall adopt the decision referred to in Article 4, Paragraph 3, line 1 of this decision no later than 7 (seven) days before the elections are held.

Article 8

All students at the Faculty enrolled in studies in the academic year 2025/2026 shall have the right to vote and be elected members of the Faculty Student Assembly.

Any full-time student at the Faculty who has passed all exams by the third semester (inclusive) and who, in addition to the application for candidacy, submits a written proposal to the Election Commission signed by at least 5% of the total number of students at the Faculty with the right to vote, may be elected President of the Faculty Student Assembly.

The candidate(s) who receive(s) the most votes from students enrolled at the Faculty who voted in the elections shall be considered elected President and members of the Faculty Student Assembly.

Article 9

This decision shall enter into force on the day of its adoption, and must be published on the Faculty's website.
